Sir,

In inviting a reference to your letter under subject cited above, I am directed to say that the Hon'ble Prime Minister in his Independence Day speech from the Red Fort last year has declared that we should abolish oral mark to the extent possible from the selection process. In the recruitment of faculties for the Assistant Professor of colleges we had abolished oral marks earlier vide Govt. O.M. No. AHE.262/2012/13 Dated 25.06.2012 and many meritorious candidates have joined in our colleges. However, the system of giving oral marks were introduced later on Vide Govt. OM No. AHE.211/2015/95 Dated 14-08-2015. Keeping in view the clarion call of our Prime Minister to make the selection process transparent and objective, it has been decided to examine through an Expert Committee as to what extent such transparency and objectivity can be achieved in the process of oral interview for the selection of a college teacher, keeping in mind the concern to select the best candidate for teaching.

Pending such examination, the Department has decided to abolish the system of awarding oral mark for the time being and cancel the Govt. O.M. No. AHE.211/2015/95 Dated 14.08.2015 and as a consequence the Govt. O.M. No. AHE.262/2012/13 dated 25.06.2012 will come into force again.

You are, therefore, requested kindly to take necessary action accordingly.
