OFFICE MEMORANDUM

Considering the situation arising out of COVID 19, the Government of Assam is pleased to waive all fees relating to admission and all other categories including examinations, festivals, publication, excursions, fees for laboratories, students union fees, college weeks, magazine fees, games & sports fees, cost of prospectus, registration fees etc. for the academic session 2020-21 irrespective of the income or the economic status of their parents.

The benefit of fee waiver will cover State Universities, Govt. Colleges, Provincialised Colleges under Directorate of Higher Education, Assam and all institutions under Directorate of Technical Education, Assam including Engineering Colleges and Polytechnic Institutes.

However, fee waiver will not include Self-financing Courses of the Colleges/Institutes and hostel admission fees. Further, hostel admission fee should not be increased during the current year. Also hostel mess dues should not be part of the fee waiver scheme.

The entire fees which will be waived, will be reimbursed by the Govt. within 30 (thirty) days from the date of receipt of the claims from the respective Colleges/Institutes. The Universities and Colleges shall project claims in terms of the uniform fees structures as notified vide No. AHE.347/2-18/12 dtd. 01.06.2019.

The Director of Higher Education, Assam and the Director of Technical Education will not wait for the demand to be received from all institutes. Even if demand is received from a single institute, the proposal will be processed for re-imbursement.

The above scheme will be applicable to the students domicile from Assam only.



In view of above, following guidelines have been prescribed in order to implement the scheme of mobility grants to the post graduate girls student under Pragyan Bharati.

Objective of the Schemes : The main objective of Mobility Grants to Post Graduate Girls Student are as below :

- (1) To attract girl students of weaker section to continue Higher Education.
- (2) Empowerment of women.
- (3) To relieve the burden of parents.

Eligibility Criteria

- : (1) Girls students studying in Post Graduate 1st year and 2nd year during the year 2022 will be eligible under the scheme.
- (2) Only regular girls students studying in State Universities and Autonomous Colleges can avail the grant.
- (3) Family income must be below Rs.5.00 Lakh

Time Frame

- : (1) Advertisement for the scheme will be issued in Daily News Paper widely circulated in Assam with 15th August, 2022.
 - (2) Girl students to submit application to the Registrar of concerned University within 1st September, 2022.
 - (3) The University Authority will submit proposal to the DHE, Assam within 15th September.
 - (4) DHE, Assam will submit proposal to the Govt. for financial sanction within 30th September,2022.

Mode of application : (1) Prescribed format for the Mobility Grants will be provided in the DHE's Web Portal

> (2) The girls student to submit their application to the Registrar of concerned University.

Sub:- Scheme for Fee waiver of admission fees, tuition fees etc. for students taking Admission in H.S./Degree and M.A./M.Sc./M. Com Courses.

In continuation of FEE WAIVER scheme under Pragyan Bharti for free admission in H.S. / Degree and M.A./ M.Sc./M. Com Courses under Higher Education Department, the scheme will continue for the year 2024-25 for those whose parental income is below Rs. 2.00 lakh.

- 1. **Aim:** The aim of the scheme in access to the poor students of the State and to help them achieve the benefits of Higher Education.
- 2. **Scope and Applicability:** The Schemes will be applicable to the students seeking admission into 1st year of H.S./B.A./B.Sc./B.Com and M.A./M.Sc./M.Com courses. Students taking admission in any self-financing course are not eligible under this scheme. In case of H.S. and B.A./B.Sc./B.Com course, those students whose fees were waived earlier will also be eligible to avail the scheme for the second year and third year admission. For M.A./M.Sc./M. Com. the benefit of the scheme is applicable for Final year for those whose fees were waived earlier.
- 3. Institutes incorporated under the scheme:
- i. All State Universities, Govt. Colleges, Govt. Model Colleges, Govt. Model Women Colleges, PDUAM, and Provincialized Colleges of Assam.
- ii. This scheme will not cover Private Colleges, Private Universities and Central Universities situated in Assam.

4. Applicability:

Category of students eligible under the scheme:

- i. Students whose parental annual income is less than Rs. 2.00 lakh from all sources will be eligible to avail this scheme.
- ii. If either of the parent (mother or father) of the student is working in the State Govt./ Central Govt./Semi Govt./State or Central Govt. undertakings, such students shall not be eligible under this scheme.
- iii. Scheme is only for regular students having minimum 75% of attendance in classes with no back paper in previous examination.

5. **Proof of Income/Documents required:**

i. An Income Certificate from the Local Revenue Circle Officer.

OR

ii. As per Govt. Notification vide No. AHE.354/2021/11 dated 13-09-2021, an alternative to the Income Certificate issued by the Circle Officer, the Head of the Institution from where a student has passed out




