Memorandum of Understanding (MoU)

Between PRAGJYOTISH COLLEGE

Guwahati – 781009 and ASOM KALATIRTHA Guwahati – 781003

This MEMORANDUM OF UNDERSTANDING (MoU) is made on the Seventeenth day of July in the year Two Thousand Twenty (17.07.2020) between **Pragjyotish College, Guwahati – 781009** and **Asom Kalatirtha, Guwahati – 781003**, which expression unless repugnant to the context, shall include its successors, agents and assignees of the First Part hereinafter referred to as **PRAGJYOTISH COLLEGE, Guwahati – 781009** and **ASOM KALATIRTHA, Guwahati – 781003**, which expression unless repugnant to the context, shall include its successors, agents and assignees of the Second Part hereinafter referred to the **ASOM KALATIRTHA, Guwahati – 781003** whereby **PRAGJYOTISH COLLEGE, Guwahati – 781003** whereby **PRAGJYOTISH COLLEGE, Guwahati – 781009** and **ASOM KALATIRTHA, Guwahati – 781003** will collaborate on different matters related to the Project on Diploma Course in Performing Arts under National Skill Qualification Framework of UGC (NSQF-UGC).

NOW BOTH PARTIES AGREE the following terms and conditions included in this MEMORANDUM OF UNDERSTANDING:

1. **PRAGJYOTISH COLLEGE, Guwahati – 781009** shall be the host institution and **ASOM KALATIRTHA, Guwahati – 781003** shall provide necessary assistance in this regard

2. The institution shall ensure to abide by the terms and conditions provided by NSQF-UGC

3. The institution shall take over the maintenance and monitoring of the different activities that shall be carried out under the Project on Diploma Course in Performing Arts under National Skill Qualification Framework of UGC (NSQF-UGC) as per stipulated guidelines

4. The Principal of **PRAGJYOTISH COLLEGE**, **GUWAHATI – 781009** (hereinafter referred to as the institution), shall be the Project Co-ordinator

5. One faculty member of the college shall be nominated as In-Charge of the Project on Diploma Course in Performing Arts under NSQF-UGC

6. Additional staff may be engaged with prior permission of UGC in accordance with the workload of courses, but within the maximum limit of the annual grant / fund allocation from NSQF-UGC

7. The institution shall provide 1 (one) or 2 (two) rooms for theory classes and 1 (one) spacious room for practical classes

8. The institution shall extend library and other training facilities to the students 9. Apart from the grants from NSQF-UGC, the institution may seek financial assistance/ grants for equipment and staff management from the State Government or from any other source as and when required

10. The Project Co-ordinator may transact such additional fund/ grants of State Government or any other organisation if available, by maintaining proper accounts (Cash Book, Pay Book, Vouchers etc.) for all such transactions

11. Both the First Part and the Second Part shall work in collaborative mode in any activity related to the Project on Diploma Course in Performing Arts under NSQF-UGC for academic activities to be conducted under NSQF-UGC

12. If any expert is invited from **ASOM KALATIRTHA**, **Guwahati – 781 003**, for academic activities to be conducted under the Project on Diploma Course in Performing Arts under NSQF-UGC, he/she will be paid remuneration, TA/DA etc. as per stipulated under NSQF-UGC guidelines

13. In the event of any practical performances by the students of **PRAGJYOTISH COLLEGE, Guwahati – 781009** in collaboration with **ASOM KALTIRTHA, Guwahati – 781003**, financial implications will be met out of institutional funds as per NSQF-UGC guidelines

14. The legal jurisdiction shall be the local jurisdiction of **PRAGJYOTISH COLLEGE, Guwahati – 781009** and **ASOM KALATIRTHA, Guwahati – 781003** if and when any legal dispute arises

15. There shall be a monitoring committee consisting of 7 members, 5 members being from **PRAGJYOTISH COLLEGE**, **Guwahati – 781009** and 2 members from **ASOM KALATIRTHA**, **Guwahati – 781003**

16. The Project Co-ordinator shall communicate with Govt. or any other external organisation/ agency for any matter as and when required, in connection with implementation/ functioning of the Project on Diploma Course in Performing Arts under NSQF-UGC

17. Any clause of this MoU may be amended if jointly felt by **PRAGJYOTISH COLLEGE, Guwahati – 781009** and **ASOM KALATIRTHA, Guwahati – 781 003**

18. This MoU may be scrapped if both parties agree and the validity of this MoU may be reviewed from time to time




