

THE MEMORANDUM OF UNDERSTANDING (MOU)

is made and entered into
On 29th Day of January 2021 by and between the

Pragjyotish College
Santipur, Guwahati -09
(First Party)

and

West Guwahati State Dispensary
Santipur Hill Side
Santipur, Guwahati -09
(Second Party)

The Memorandum of Understanding (MOU) with West Guwahati State Dispensary is to facilitate the working of the First Aid Centre of Pragjyotish College, so that the teaching, non-teaching staff and the students get the maximum benefit from it.

SCOPE AND MODALITIES:

- There will be display of the West Guwahati State Dispensary contact number of the physician.
- There will be display of the contact No. of the nurse of West Guwahati State Dispensary
- In case of emergency, patient will be sent to the West Guwahati State Dispensary.
- The West Guwahati State Dispensary will provide free medicine (if available) to the patient sent by the college.
- This is a non-binding MoU and there will be no financial obligation on the West Guwahati, State Dispensary as a partner in MoU.

Both the Pragjyotish College and West Guwahati State Dispensary agree that any information which is exchanged pursuant to this MoU will be kept strictly confidential

and used solely for the purpose, covered by this MoU, unless such information was obtained by a third party who does not have an obligation of confidentiality-disclosing party and entered public domain.

Subject to clauses below, both the institutions may attend this MoU by mutual consent in writing. Any amendment agreed by the institutions shall come into effect from the date determined by the signing Institutions on potential areas

This MoU shall enter into force on the date of signing and shall initially be valid for a period of three years. Thereafter, the Institutions, namely Pragjyotish College and West Guwahati State Dispensary, shall agree on mutual consent on the continued validity of this MoU. However State Guwahati State Dispensary has freedom to continue or discontinue the MoU at its own discretion.

In any other circumstances, or other detailed collaboration between the two parties, a separate MoU shall be drawn up as and when required.

The Institutions i.e. Pragjyotish College and West Guwahati State Dispensary agree that this Memorandum of Understanding Shall enter into forces on the basis of goodwill and shall not be legally bound. Nothing mentioned in this MoU shall deem constitute partnership between the shining institutions appointing one party as an agent of the other. This MoU will be effective upon signature by both Pragjyotish College and West Guwahati State Dispensary for a period of three years. At which time it will be reviewed for possible renewal for further period of three years. Either party may, on three (3) months' notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions
