



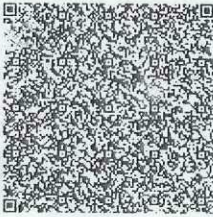



The NGO agrees to work with the College to ensure that students are provided with appropriate job training and interview preparation.


The NGO also agrees to explore the internship opportunities for the students of the College.
